### What is EISA?

The External Integrated Summative Assessment (EISA) is a national, standardized assessment conducted by an Assessment Quality Partner (AQP) and managed by the Quality Council for Trades and Occupations (QCTO). It assesses the learners' competence against the Exit Level Outcomes of a qualification, ensuring they are competent workers upon completion. Learners enter the EISA through a Statement of Results (SoR) issued by their Skills Development Provider (SDP) or institution via the Recognition of Prior Learning (RPL) route.

### QCTO Learner Registration & EISA Process

- ✓ **Learner Registration:** Ensure all learners are registered with the QCTO for the specific Occupational Qualification. Use the QCTO learner enrolment template and submit it within 21 days after the training starts to [Learnerenrolments@qcto.org.za](mailto:Learnerenrolments@qcto.org.za).
- ✓ **Training Components:** Learners must complete the Knowledge, Practical, and Workplace Experience components during their training. All assessments must be conducted by the Skills Development Provider (SDP) throughout this phase.
- ✓ **Statement of Results:** Once learners meet the requirements for all three components, the SDP will issue a Statement of Results (SoR), confirming their readiness for the External Integrated Summative Assessment (EISA).
- ✓ **Scheduling EISA:** Check the QCTO EISA schedule to select the appropriate assessment date and centre. Submit the updated learner enrolment and readiness form to [EISAreadiness@qcto.org.za](mailto:EISAreadiness@qcto.org.za). EISA dates close 3 months before the scheduled exam, so plan accordingly.
- ✓ **Confirmation & Quality Assurance:** Learners will receive confirmation of their EISA date and details. After completing the EISA, the QCTO and AQP will perform quality assurance on the assessments.
